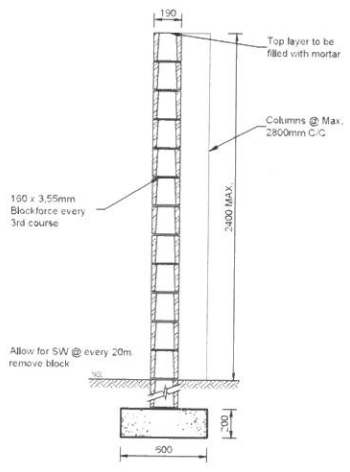

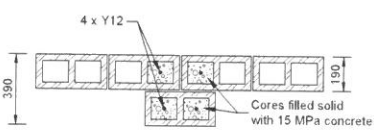

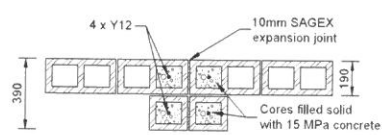
TYPICAL SECTION THROUGH WALL

SCALE 1:25

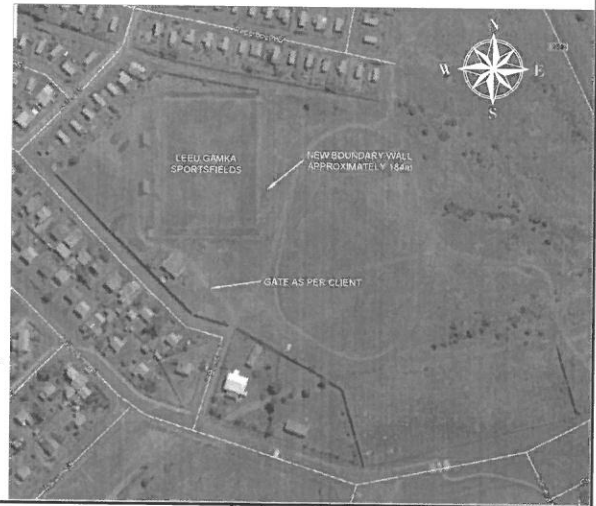


TYPICAL COLUMN SECTION WITHOUT EXPANSION JOINT
