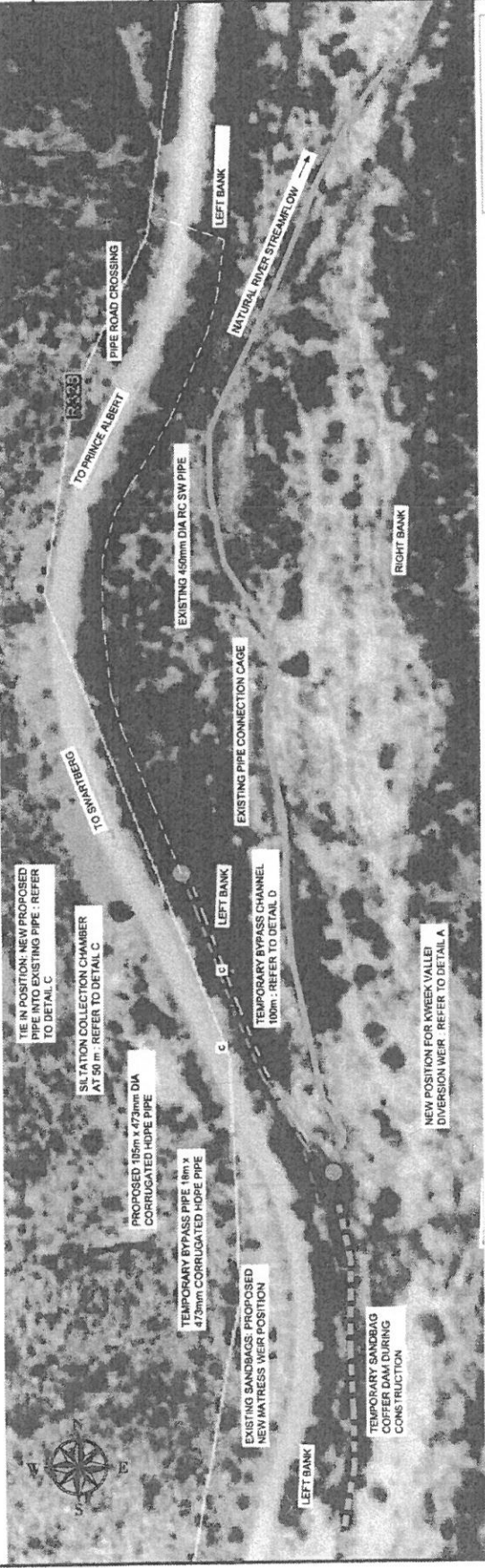
NATURAL RIVER STREAM FLOW DIRECTION
