1. INTRODUCTION AND BACKGROUND

Section 116(3) of the Municipal Finance Management Act (Act 56 of 2003) (MFMA) prescribes that public participation is required whenever a local authority intends to amend or extend a contract procured through its municipal supply chain management policy.

2. SECTION 116(3) PROCESS TO BE FOLLOWED

Section 116 of the MFMA refers to the section regarding **CONTRACTS AND CONTRACT MANAGEMENT**. As required by the MFMA, a municipality is therefore required to provide information and to invite written comments from the local community and affected parties and/or persons for the proposed amendment of contracts procured through the municipal supply chain management policy.

Section 116(3) of the MFMA stipulates the following:

- 3) A contract or agreement procured through the supply chain management policy of the municipality or municipal entity may be amended by the parties, but only after
 - a) the reasons for the proposed amendment have been tabled in the council of the municipality or, in the case of a municipal entity, in the council of its parent municipality; and
 - b) the local community—
 - (i) has been given reasonable notice of the intention to amend the contract or agreement; and
 - (ii) has been invited to submit representations to the municipality or municipal entity.

3. PROJECT BACKGROUND

The situation is caused by the damage to the Prince Albert Municipal production boreholes and water supply infrastructure when we experienced high intensity seasonal rainfall as recent as 25 September 2023 as well as during a prior event on May 2023 the conveyance infrastructure was destroyed.

This intense rainfall gives rise to the Dorps River discharge/flow velocity and current increasing exponentially, as well as widespread overland flow. Change of the course of flow also resulted in, not only damaging the borehole headworks, but also the conveyance pipeline infrastructure, which is essential for ensuring the town's (Prince Albert) daily water supply is delivered to the water treatment works and ultimately the residents.

5. FINANCIAL IMPLICATION OF AMENDMENT

Section 116 of the Municipal Finance Management Act (Act 56 of 2003), read together with MFMA Circular 62 (Supply Chain Management, enhancing compliance and accountability) states that contracts may be expanded or varied by not more than **twenty percent (20%) for construction related goods**, services and/or infrastructure projects and **fifteen percent (15%) for all other goods and/or services** of the original value of the contract.

Below is an indication of the financial implications for such contract amendment:

This project will be funded from the Water Services Infrastructure Grant (WSIG) and funding from Provincial Treasury.

6. MOTIVATION FOR AMENDMENT

Tender 98/2023 was awarded to Active Phambili Civil Contractors during October 2023 after the Intention to Award on 15 June 2023 due to awaiting the outcomes of the roll over funding application by National Treasury. During this period Active Phambili Civil CC was requested to extend the tender validity to 30 November 2023 subsequent to the storm event and further damages to the conveyance infrastructure during September 2023, the extension of validity was accepted. However, the damages experienced during the storm event stated above gave rise to a several statutory approvals that had to be obtained from the respective Authorities before the Works could commence. The timeline of events for acquiring these are outlined below:

- 04 May 2023 Meeting with Dept of Infrastrucutre (DoI) in Council Chambers, Prince Albert to discuss Wayleave approval conditions
- 05 June 2023 -This Branch's Dept. Of Infrastructure (Wayleave approval) letter TPW/CFS/RP/LUD/WLWP-23/08 (Job 29090a) dated 5 June 2023, Wayleave Approval issued to the Municipality of Prince Albert.
- 05 June 2023 Issued Letter Job 29090c stating This Branch's 5 June 2023 approval letter is in support of the installation of the water pipe only. This Branch does not support Lyners Consulting Engineers' proposed electrical cable installation immediately adjacent to the road. This Branch recommends that the electrical cable is installed adjacent to the approved pipeline along the river's western bank, almost similar than the existing cable installation. this condition has since been agreed to.

These uncontrollable variables as expected has had an adverse impact on the project timeframe for implementation and by extension to the project costs thus resulting in the need to expand/amend and for variation of the contract.
