Prince Albert Municipality hereby invites tenders for the CONSTRUCTION OF WATER AND SANITATION INFRASTRUCTURE IN WELGEMOED-NORTH AND NEWTON PARK, LEEU GAMKA. The project entails the construction of a 1ML reinforced concrete circular potable water Reservoir and a reinforced concrete sewage pump station. A set of tender documents must be reserved at least 48 hours prior to the date of the compulsory clarification meeting at the consulting engineer (SMEC South Africa). Tender documents will be available at a non-refundable cost of R 800.00 (VAT Included), payable in cash at the cashiers at the Prince Albert Municipality's Financial Division, Thusong Centre, Adderley Street, Prince Albert 6930 or EFT deposit in favour of the Prince Albert Municipality ABSA Bank, Account number 26-4056-0064 Reference: T74/2024 and company name.

Bidders are required to be registered with the Construction Industry Development Board (CIDB). Only those tenderers who are registered with the CIDB, in a contractor grading designation equal to or higher than a contractor grading designation determined in accordance with the sum tendered, or a value determined in accordance with Regulation 25 (1B) or 25 (7A) of the Construction Industry Development Regulations for a **7CE** class of construction work are eligible to have their tenders evaluated.

A compulsory tender clarification meeting will be held at **09H30** on **26 June 2024 at the EE-Centre (Corner of R407 Road and Toegangs Road, North End, Prince Albert, 6930)**. Following the tender clarification meeting, a **compulsory site visit** will be held at Leeu Gamka. **Tenderers are required to attend both the Tender Clarification Meeting and Site Visit to be eligible to tender.**

Bids must be submitted in sealed envelopes, clearly marked with the tender number and tender description. Bidders that fail to adhere to this requirement, will be disqualified at the bid opening. Late or unmarked bids will not be considered. Telegraphic, telephonic, telex, facsimile, e-mail and late bids will not be accepted.

Bids must be deposited in the tender box at the Finance Division (Thusong Centre, Adderley Street, Prince Albert, 6930). The tender box will be open as follow:

Monday to Thursday: 07h30 and 16h00 Fridays: 07h30 and 15h30.

Bids will be opened in public immediately after the closing date at the Finance Division Boardroom (Finance Building, Thusong Centre).

This bid is subject to functionality scoring. Bidders must obtain the minimum functionality scoring for the bid to be regarded as responsive. Bids that do not meet the minimum functionality scoring, will be regarded as non-responsive, and will not be evaluated on price and preference points.

Bids will be evaluated according to the 80/20 preference points system. The bids are subject to the Council's Supply Chain Management Policy, the Municipal Preferential Procurement Policy, and the Preferential Procurement Regulations, 2022 (Government Gazette 47452, dated 04/11/2022). The General Conditions of Contract is also applicable. **Tenderers must be registered on the Central Supplier Database (CSD) if they wish to conduct business with the municipality.**

The preferential points system applied (80/20) in terms of the Preferential Procurement Policy are as follow:
