	R400,000 per month will be used for calculation, but the BOQ Item 3.1.1. Transaction Fee
	(%) refers to R5.5 million Monthly. When completing the BOQ, should the R400,000 be
	used to complete the calculation as opposed to the R 5.5 million?
	Response: The correct amount must be R 400 000 and not R 5.5 million.
	The Description of the Tender state the contract period from July 2022 to June 2025, But
2.	on page 15 - item 18, the Commencement Date state from July 2022 to June 2027. Kindly
	advise the actual end term of the contract either 2025 or 2027 (noting the contract start is
	from date of award).
	Response: The actual end term of the contract is 2025.

On page 14, Item 11.2 Migration of Data and Commissioning of New System, it is stated that the data must be migrated, and the new system commissioned by 01 July 2022. Also, Training Pg 15, Item 12.3 state training must be completed by 01 July 2022. Based on the Closing date of this tender 21 June 2022, allowing some time for SCM adjudication and assuming 14 to 21 days allowance for any objections, is it safe to presume that this tender will not be awarded before 01 July 2022? Also based on this assumption, should we plan for full commissioning and Go-Live by 01 Aug 2022 (subject to successful contract award and the provision of data from the existing service provider)?

Response: It all depends the date of tender award. The municipality can go-live by 01 August / September, but all depends on the completion of the procurement processes.
