1. INTRODUCTION / SCOPE OF WORK

Prince Albert Municipality hereby invites formal written price quotations for the Mixing and Delivery of Ready Mixed Bituminous Slurry to Bitterwater Sportsfield, Leeu-Gamka.

2. DESIGN MIX

A design mix will be provided to awarded service provider is to prepare a design mix and submit it to an accredited laboratory for a Marshall Test, at the service providers cost.

3. ASPHALT FILLER

An asphalt filler might be added to the design mix. The design mix for this modification will be provided by Prince Albert municipality or its agent.

4. WATER

Water will be provided by Prince Albert municipality

5. MIX DESIGN PROCEDURE

A Marshall test is to be carried out by Prince Albert Municipality to determine the optimum bitumen content for the crusher dust to be used. The bitumen content will vary depending on the aggregate source and grading. The typical bitumen content of the slurry should be between 8% and 10% per mass of the dried slurry.

6. PAINTING OF LINES

Application of court lines should be done with standard white road-marking paint. Inferior paint will not be accepted.

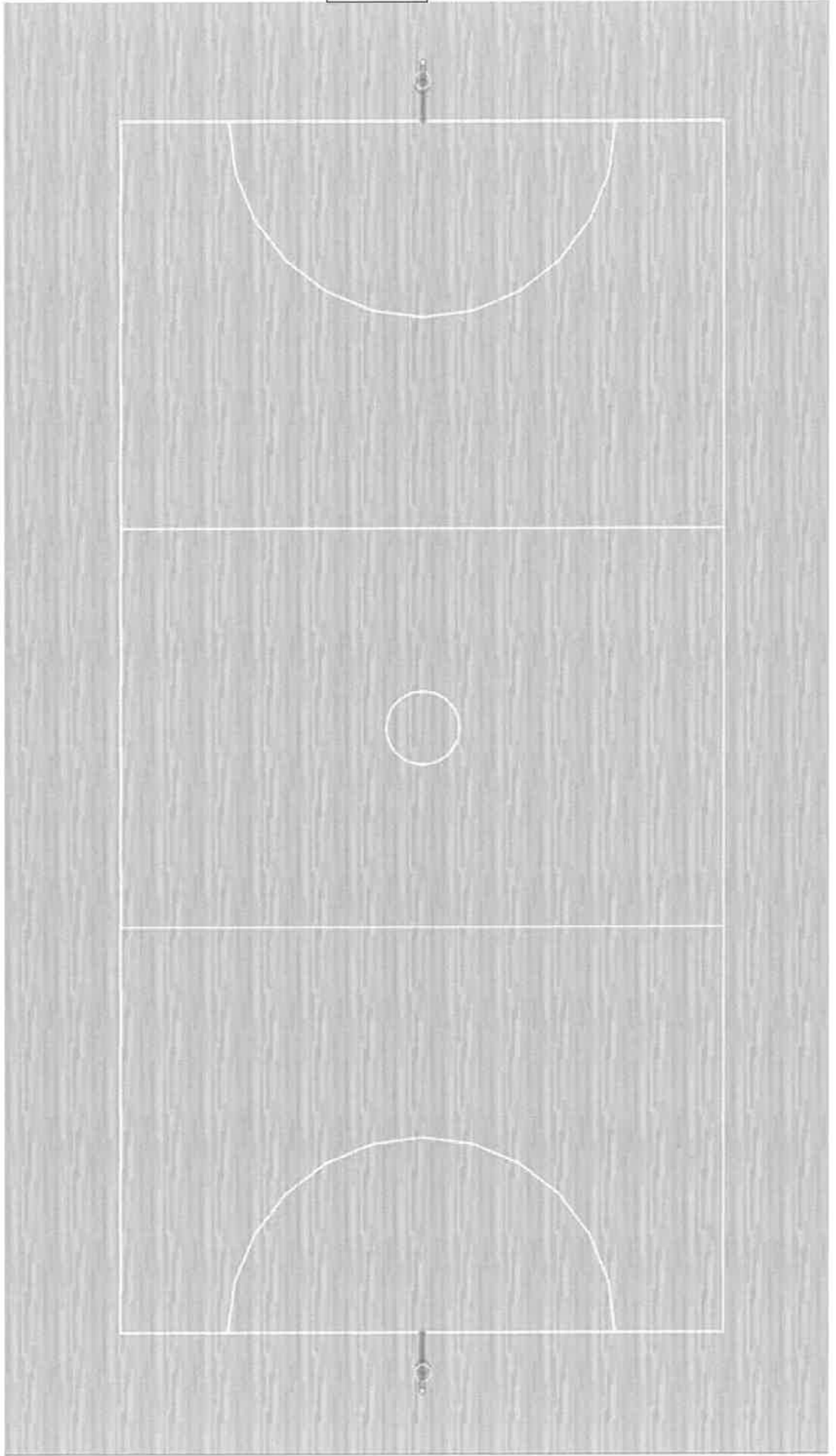

This Municipal Bidding Document (MBD) must form part of all bids invited. It contains general information and serves as a declaration form for local content (local production and local content are used interchangeably).
