#### **INSTRUCTIONS**:

- 1. Prince Albert Municipality hereby invites quotations for the supply and delivery of various printer cartridges for a period until 30 June 2023.
- 2. The successful bidder will enter into a service level agreement with the Prince Albert Municipality.
- 3. The contract period will commence from the date of award and is for a period ending 30 June 2023.
- 4. Prospective bidders must quote for all the items listed as per the pricing schedule
   failure to comply will result in the bid being declared non-responsive.
- 5. Cartridges will be requested by the municipality on a quarterly basis. An official purchase order will thus be issued after an official request is sent to the appointed service provider. The service provider must issue a formal quotation to the municipality for the various items in accordance with the tendered rates.
- 6. All products must be SANS or SABS compliant. Failure of products to comply with these standards the bidders' quotation will be made not responsive.
- 7. No generic cartridges will be allowed.

#### PRICING:

- 1. All prices must include VAT. If the bidder is not registered for VAT, do not include VAT in the price.
- 2. Prices should be fixed for a period of one (1) year. Prior to accepting any major price increases written proof must be supplied from manufacturers. Acceptance of the price increases are subject to the approval of the Director: Financial Services or his delegate after satisfying himself that these increases are in line with the industry norm.

#### **DELIVERY**:

- 1. Delivery must occur within ten (10) working days or as agreed with the client after placement of a purchase order.
- 2. Delivery will take place on a quarterly basis, meaning that 4 deliveries will be made during the agreement. Bidders will not be allowed to deliver the full batch of cartridges once-off.

## PREFERENCE POINTS CLAIM FORM IN TERMS OF THE PREFERENTIAL PROCUREMENT REGULATIONS. 2017

- (c) "bid" means a written offer in a prescribed or stipulated form in response to an invitation by an organ of state for the provision of goods or services, through price quotations, advertised competitive bidding processes or proposals;
