## **2. SCOPE OF WORKS & AREAS OF FOCUS**

Prince Albert Municipality requires the services for the provision of occupational health services. Occupational health services shall be provided by the services provider by means of clinic, mobile clinic and or offsite unit. The service provider must have offices in the Western Cape region within a radius of < 250km to Prince Albert Municipal Offices.

### **The following services should be rendered to Prince Albert Municipality:**

- a) The supplier must render medical services in terms of the applicable statutory and ethical requirements.
- b) Development of an appropriate medical surveillance programme based on risk exposure. The programme should include biological monitoring, biological effect monitoring and immunisations.
- c) Conduct medical surveillance with the assistance of an Occupational health nursing practitioner (OHNP) to determine employee's fitness to or the effect of working conditions where hazards might pose a threat in terms of health and safety.
- d) Provide Occupational Medicine Practitioner to oversee, verify and interpret the results.

### **Medical Surveillance.**

Medical examinations to be conducted to determine employee's fitness to perform work they have been appointed to perform, if potential or current employees suffer from any ill health or occupational disease due to any hazards suffered as a result of operational activities

Risk based routine medical examinations

### **Pre placement medical examination.**

- a) An evaluation of the employee history of general health and previous occupational health.
- b) General health interview.
- c) Comprehensive screening questionnaires (e.g., sleep disorder, Physiological problems, shift work, Muscular skeletal, heat/cold work,

skin assessment, Audiometric, respiratory, occupational exposure, etc.).

- d) Blood pressure measurement, urine analysis, glucose test, Audiometric screening, Lung function screening, Chest X rays, visual screening, medical and physical examination, multi drug and alcohol testing, etc.).
