# REQUEST FOR FORMAL WRITTEN PRICE QUOTATION (RFQ) MONITORING OF THE ULTRA FILTRATION AND REVERSE OSMOSIS WATER FILTRATION PLANT AT LEEU GAMKA WATER TREATMENT WORKS, FOR THE PRINCE ALBERT MUNICIPALITY.

#### **INTRODUCTION**

The Leeu Gamka Water Treatment Works (WTW) was completed in the 2016/17 financial year, funded by Department Human Settlement and constructed by the Implementing Agent, ASLA, as part of the upgrade of the water supply to the Transnet area in Leeu Gamka.

The project entailed the treatment of the Transnet borehole yield, which though was of high quantity, deteriorated in quality. It was found that the Flouride levels of the yield were outside and above the potable water norms. This implied that the borehole was to be decommissioned, which would have led to an untenable situation, as the borehole supplies a high percentage of the water demand.

The system utilizes Reverse Osmosis and Ultra Filtration to separate and dilute the Flouride and provide a very good quality of water. The system however comprises of very expensive and sensitive equipment and telemetric monitoring and oversight of the highly specialised equipment is needed

#### **LOCATION OF LEEU GAMKA WATER TREATMENT WORKS**

The Leeu Gamka Water Treatment Works is located just off the Bitterwater Access Road along the N1 National Highway approximately 388 km North East of Cape Town in the Karoo. GPS Co-Ordinates are as follow:

#### EXTENT OF THE SERVICES TO BE PROVIDED

#### 1. Monitoring and Support services

- The Service provider must be available on a continuous basis for the assistance for fault finding, changing of PLC Parameters, CIP etc.
- Any alterations or changes on the system by the Prince Albert Municipality
  on the plant will be communicated to the service provider and all changes
  by both parties to be recorded.

#### 2. Monthly Plant Visits

- Report on the integrity test done on all the membranes.
- Training as and when required.
- Identify and report maintenance requirements to the Prince Albert Municipality.
- Optimize RW Plant as required and to be reported to the Prince Albert Municipality.
- CIP will be done if required.
- Perform PDT testing and backwashes as the need arise.
- Check set point ranges and performing shutdown to test controls.
- Check the preventative maintenance which has been done by the Prince Albert Local Municipality.
- Immediately alert the Prince Albert Municipality when health/safety or operational hazards are detected.
- Record keeping of all visits.

#### 3. Reporting

- A complete report within 7 days of each visit must be submitted to the Prince
   Albert Municipality and must include the following:
- Routine and preventative maintenance required.
- Treatment plant failures and problem areas
- Recommended maintenance requirements.
- Plant Performance.
- Feedback on the Integrity of the membranes.
- Water Samples taken.

#### **EXPERIENCE OF SERVICE PROVIDER**

The Service Provider must have past experience in the design, installation, commissioning, maintenance and operation of Ultra Filtration and Reverse Osmosis Systems.

#### **DURATION**

The Service Provider must be able to provide the required service on a month to month basis from the date of commencement / signing of service level agreement for a period of four (4) months, up to the 31 October 2021.


