**1. INTRODUCTION**

Prince Albert Municipality hereby invites formal written price quotations from suitably qualified and experienced service providers for the redesign of the municipal website.

**2. CONTRACT PERIOD**

This is a once-off project.

**3. SPECIFICATIONS:**

**3.1) Design**

- 3.1.1) Must be developed on a modern, widely used Content Management System compatible with standard Linux hosting platforms provided by the majority of hosting companies and that can in the future be maintained by the Municipality.
- 3.1.2) A mock-up of colours, fonts and layout must be presented and approved by the Municipality prior to implementation.
- 3.1.3) The site must be responsive (automatically adapting to all the widely used industry standard device screen sizes).
- 3.1.4) Must be compatible with all major browsers. Specifically, Microsoft Edge, Google Chrome / Chromium, Mozilla Firefox, Apple Safari, and all the major mobile browsers for Android and IOS devices.



### **3.2) Functionality:**

- 3.2.1) The CMS Must be search engine friendly.
- 3.2.2) The site must present the consumer with the ability to perform a full text search of all information on the site.
- 3.2.3) A primary news feed must be available on the front page.
- 3.2.4) The CMS must provide the Municipality with the ability to add as many other news or content feeds as is required for its purposes and to link these feeds to menu items.
- 3.2.5) The layout must have regions where the Municipality can draw attention to important topics (banners, side bars, blocks).
- 3.2.6) The site must have a section where the Municipality can post notices in the form of PDF documents with a heading and description.
- 3.2.7) An event calendar must be present and it must allow the Municipality to publish multiple calendars, each containing multiple events.
- 3.2.8) The site must have a documents repository which allows the Municipality to publish statutory required documents and has at least the following features:
  - The ability to categorize documents.
  - The ability to organize documents in a multi-level hierarchical structure with no limit on the number of sub-levels.
  - The ability to publish and browse the hierarchical structure or parts thereof on the website.
  - The ability to publish and un-publish individual documents.
  - The ability to add an expiry date to documents which will automatically un-publish the documents after the expiry date has been reached.
  - Metadata for all documents (at least a heading, description and publication date).
  - The ability to attach one or more files to a document.  
The ability to link any menu item on the site to a specific part of the hierarchy.
- 3.2.9) A Photo gallery section where multiple photo galleries can be hosted, each containing multiple photos. The CMS must automatically generate thumbnails and have the ability to resize and standardize all images in the galleries without the need for graphics editing software.

- 3.2.10) The site must have a section to publish tenders and Requests for quotations. It must have the ability to distinguish between currently active, cancelled, recently awarded and archived tenders.
- 3.2.11) Job Register with sections to upload application forms and currently available jobs.

1.6 The purchaser reserves the right to require of a bidder, either before a bid is adjudicated or at any time subsequently, to substantiate any claim in regard to preferences, in any manner required by the purchaser.

## 2. DEFINITIONS

- (a) “**B-BBEE**” means broad-based black economic empowerment as defined in section 1 of the Broad Based Black Economic Empowerment Act;
- (b) “**B-BBEE status level of contributor**” means the B-BBEE status of an entity in terms of a code of good practice on black economic empowerment, issued in terms of section 9(1) of the Broad-Based Black Economic Empowerment Act;
- (c) “**bid**” means a written offer in a prescribed or stipulated form in response to an invitation by an organ of state for the provision of goods or services, through price quotations, advertised competitive bidding processes or proposals;
- (d) “**Broad-Based Black Economic Empowerment Act**” means the Broad-Based Black Economic Empowerment Act, 2003 (Act No. 53 of 2003);
- (e) “**EME**” means an Exempted Micro Enterprise in terms of a code of good practice on black economic empowerment issued in terms of section 9 (1) of the Broad-Based Black Economic Empowerment Act;
