1. INTRODUCTION

The Prince Albert Municipality is a registered Water Service Authority which is responsible for the provision of potable drinking water that complies with the National Standards in terms of SANS 241-1:2015 to the towns of Prince Albert, Prince Albert Road. Leeu-Gamka and Klaarstroom. Along with this the Prince Albert Municipality is also mandated to collect and treat the waste water generated in these towns to comply with the standards as prescribed by the Department of Water and Sanitation for Irrigation as well as for discharge into the natural receiving environment.

The Prince Albert Municipality being a Water Services Authority is required to collect on a monthly basis potable water samples at various sampling points for submission to a testing laboratory for analysis to determine compliance with national standards for drinking water, samples of treated waste water is also collected for analysis to determine effluent quality and whether it meets the requirements for irrigation or discharge. It is for this reason that the services as outlined below of a recognised and reputable laboratory is required.

- The Service Provider must have past experience in the provision of laboratory services for the analysis of water and waste water.
- The service provider must also submit proof of participating and achieving *satisfactory status for the proficiency testing program as accredited by SANAS, Ref: PTS0003, in accordance with the requirements of ISO/IEC 17043:2010 "General Requirement of Proficiency Testing Providers. * Satisfactory Status is achieved when ≥50% of z-scores are ≤2.
