1. GENERAL

Prince Albert Municipality is in need of an Labour Relations Expert / Legal Practitioner / Officer to conduct an investigation into alleged misconduct by Senior Management in terms of Section 5 (3)(a) of the Disciplinary Regulations for Senior Managers.

The Council specifically wishes to appoint a suitably qualified and experienced service provider to assist in gathering and assessing or analysing information or evidence with a view to establish whether there is reasonable cause to believe that an act of misconduct has been committed by any Senior Management official (s).

2. SERVICE PROVIDER APPOINTMENT REQUIREMENTS

Appointment requirements of the Initiator / Service Provider:

- 2.1) Chartered Human Resource Practitioner or Admitted Attorney with proven track record of at least 5 years on the following:
 - 2.1.1) Handling of disciplinary processes process against employees at a senior level of management.
 - 2.1.2) Knowledge of Rules of Evidence and Procedures
 - 2.1.3) Knowledge of disciplinary processes in the public sector
 - 2.1.4) Knowledge of Municipal Finance Management Act (MFMA), Treasury Regulations_including Regulations of Irregular Expenditure and wasteful and fruitless expenditure
 - 2.1.5) Service providers must provide a minimum of three contactable References.
 - 2.1.6) Comprehensive CV of Project Manager / Investigator must be submitted.

2.1.7) Service provider must be registered as a prospective supplier on the Central Supplier Database (CSD) as required in terms of National Treasury Circular No. 3 of 2015/2016 and National Treasury SCM Instruction Note 4 of 2016/2017.

3. SCOPE OF WORK
