1. It will be required of the successful bidder to remove all building waste from the premises which resulted from this job.
2. The successful bidder must use high quality curtain material/ fabric for this project.
3. **Option 1:** Curtains should fabric material should be of high quality.
4. **Option 2:** Only 50 mm Aluminium Venetian blinds with a slab thickness of 0.21 mm will (matte dark brown in color). The fitting type is recess and the controller is on the right-hand side.
5. The successful bidder must provide the material that is needed for this job.
6. The successful bidder must provide their own equipment, tools and small plant that will be required to complete the project successfully.
7. The successful bidder must commence with work within 7 days after official municipal purchase order has been issued.
