Prince Albert Municipality is a category B-municipality situated in the Central Karoo, Western Cape. With a staff establishment of 101 staff members, the Municipality requires a suitable qualified service provider to develop standard operating procedures for its Technical and Community Services departments to improve service delivery, a transfer of skills and accountability.

This Municipal Bidding Document (MBD) must form part of all bids invited. It contains general information and serves as a declaration form for local content (local production and local content are used interchangeably).

- 1.5. The local content (LC) expressed as a percentage of the bid price must be calculated in accordance with the SABS approved technical specification number SATS 1286: 2011 as follows:

x is the imported content in Rand

y is the bid price in Rand excluding value added tax (VAT)

Prices referred to in the determination of x must be converted to Rand (ZAR) by using the exchange rate published by South African Reserve Bank (SARB) at 12:00 on the date of advertisement of the bid as indicated in paragraph 4.1 below.
