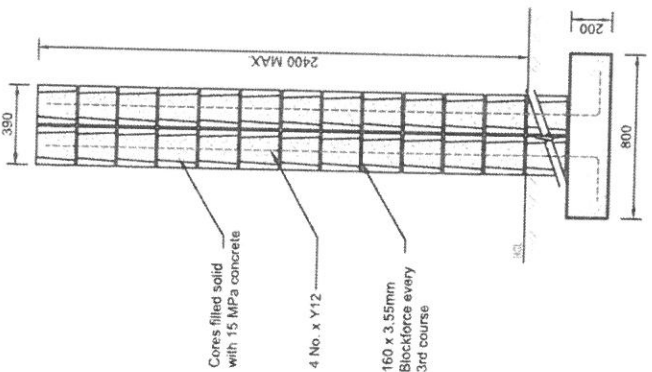

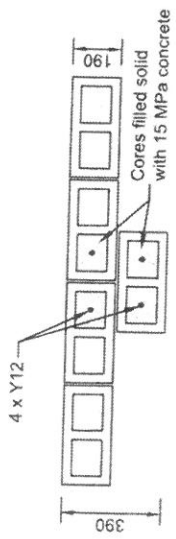

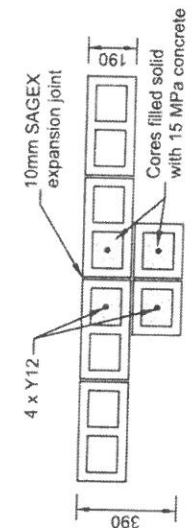
TYPICAL SECTION THROUGH WALL
SCALE 1:25



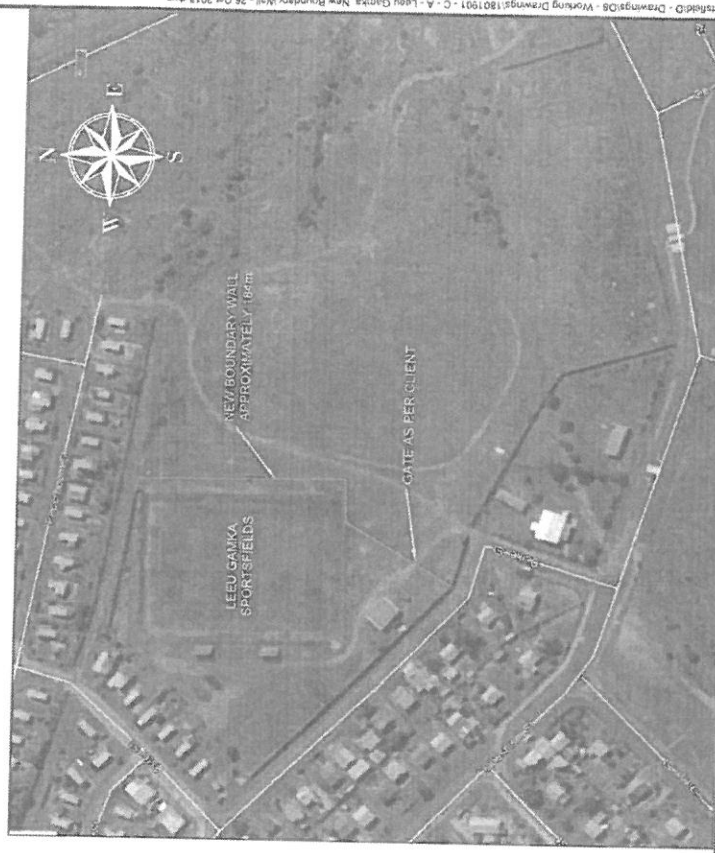
TYPICAL SECTION THROUGH COLUMN
