Quotations are hereby requested from bidders to operate and manage the municipal pre-paid electricity vending point in North-End (Rondomsikrik).

- The successful bidder will enter a contract with the municipality. The contract period for the above-mentioned bid will be from 01 July 2021 or date of signing the service level agreement / contract until 30 June 2022.
- A commission of 5% of the prepaid electricity sales shall be paid to the bidder.
