This quotation will be evaluated in terms of the 80/20 preference point system as prescribed in the Preferential Procurement Policy Framework Act (No 5 of 2000) and for this purpose the MBD 6.1 and MBD 6.2 (**Local content**) form must be scrutinized, completed and submitted together with your quotation.

INSTRUCTIONS

1. This is a rates-based quotation.
2. The Successful Bidder's Rate per Square (Rand/m²) is for (1m x 1m) square meter size completed. Smaller m² done (fractions thereof) will be paid according to the actual measurements.
3. Prince Albert Municipality will issue an order and appointment letter to successful Contractor, which will serve as the binding documents between the two parties.
4. The Successful Contractor must commence work within 5 calendar days receipt of official purchase order.
5. Prince Albert Municipality's representative will instruct Contractor of areas to be repaired.
6. Contractor will complete check sheet, and Prince Albert Municipality's representative will do final sign-off. These check sheets will mainly be used for Payment Certificates and the quantities will be verified by the Municipality.
7. The Contractor must supply **all materials, labour, transport and plant**.
8. Defects liability: Repaired areas will be monitored for a period of 6 months. If any defects should occur the contractor will be held responsible (defects include – Sagging, heaving, rutting, ravelling, cracking, edge break up, etc).
9. Potholes may not be left open overnight – any remedial work started must be finished on the same day.
10. All technical specifications to be as per SANS 1200 (SABS 1200).

REGISTRATION AT THE CONSTRUCTION INDUSTRY DEVELOPMENT BOARD

SCOPE OF WORKS

Method statement: Remedial Method / Steps to be followed:

1. The Contractor must plan the work so as to minimize any Public / Traffic disruption.
2. Park all construction vehicle(s) in a safe and appropriate place as to minimize Public/Traffic disruption.
3. Place adequate road signage, construction boards, flagmen where needed.
4. All workers must wear reflective vests.
5. Neatly pick (or Saw-cut-depending on the size) the affected area, in a square (or rectangle) shape.
6. The section removed must be slightly larger than the actual excavated area, maximum 40 – 50mm border around excavated edges (No unnecessary enlarging the remedial area for additional payment purposes).
7. Remove material min 15 – 20mm deep; use straight edge and tape measure to verify depth so as to produce a smooth level and flat surface.
8. For potholes deeper than 50mm: Base to be repaired with G5 material and compacted (use walk-behind roller or rammer– depending on size of pothole). Care must be taken not to break the existing tar edges.
9. Sweep and clean the area until all loose material / debris is removed and surface is neat and tidy.
10. Tack coat inside, including the sides and top edges/ overspill.
11. Fill with cold mix , min 20 – 30mm thick, approximate 5 – 10mm above road surface.
12. Compact the loose mix with a pedestrian roller until sufficient compaction is obtained.
13. Moisten surface lightly with water and re-compact a second time until a brown bitumen sledge appears on the surface. Sweep/wipe road surface clean.
14. Final surface must be level with surrounding road level – no heaving or sagging.
15. Clean entire remedial area – road, sidewalk, SW channels – from any construction debris/rubble.

 - (a) disqualify the person from the bidding process;
 - (b) recover costs, losses or damages it has incurred or suffered as a result of that person’s conduct;
 - (c) cancel the contract and claim any damages which it has suffered as a result of having to make less favourable arrangements due to such cancellation;
 - (d) recommend that the bidder or contractor, its shareholders and directors, or only the shareholders and directors who acted on a fraudulent basis, be restricted by the National Treasury from obtaining business from any organ of state for a period not exceeding 10 years, after the *audi alteram partem* (hear the other side) rule has been applied; and
