Specifications:

1. INTRODUCTION / BACKGROUND

Prince Albert Municipality requires the services of a competent contractor to supply, deliver and install air conditioners in the municipal buildings in the Prince Albert municipal area.

2. SCOPE

- a) Supply and delivery of new air conditioning units to the various towns in the municipal area.
- b) Installation of new air conditioning units including all electrical ducting, wiring, switchgear, copper piping and galvanized mounting brackets (as per schedule below).

2. CIDB GRADING

Bidders are required to have a CIDB contractor grading of at least **1 ME** to be eligible to submit a bid. Proof of such registration must accompany such bid. No bids will be accepted from bidders who do not comply with the grading requirements.

3. VALIDITY PERIOD OF QUOTATION

The tender/quotation must be valid for a period of 30 days after closing date.

4. PRICING

- a) Non-compliance with the agreed delivery time, quality, quantity and prices agreed could lead to the supplier being held liable for any expenses incurred as a result thereof.
- b) The Tendered Price must include VAT. If the bidder is not a registered VAT vendor, it must be indicated as such on the Pricing Schedule.

5. DELIVERY

- a) The supply, delivery and installation of new air conditioner units must take place be within 14 calendar days after receipt of an official purchase order.
- b) Installation of the aircons must be done immediately after delivery of the aircons.
- c) No exceptions will be allowed.
- d) The delivery and installation will take place at the following towns:
 - Prince Albert – EE-Centre (delivery and installation)
 - Leeu-Gamka Municipal Office (delivery and installation)
 - Klaarstroom Municipal Office (delivery and installation)
- e) Bidders must ensure that they familiarise themselves with the route between the various towns in the municipal area in order to determine the travelling costs, estimated completion time of installation and disbursements.
- f) The delivery of the required air conditioners must be done within 7 days of receipt of an official purchase order

6. WARRANTY

The bidder must be able to provide the following warranty:

- a) 2-year warranty on all air conditioners
- b) 1-year warranty on all workmanship

Proof of such warranty must accompany the quotation.
