**TENDER 45 / 2021: DESIGN AND CONSTRUCT OF PAVILION ROOFS FOR THE ODENDAAL SPORTS FIELD IN PRINCE ALBERT AND BITTERWATER SPORTS FIELD IN LEEU-GAMKA, FOR THE PRINCE ALBERT MUNICIPALITY.**

Prince Albert Municipality hereby invites tenders for the design and construction of pavilion roofs for the Odendaal Sports Field in Prince Albert and the Bitterwater Sports Field in Leeu-Gamka, for the Prince Albert Municipality. Tender Documents are available at no charge from the Prince Albert Municipality Website at [www.pamun.gov.za](http://www.pamun.gov.za) (Website navigation is as follow: Procurement, Tenders available). Tender documents will be available from 12 April 2021.

A **compulsory tender clarification meeting at both sports fields** will be held on Wednesday 14 April 2021 at the Odendaal Sports Field in Prince Albert (Odendaal Street, Prince Albert, 6930) at 11H00, and 14H00 at the Bitterwater Sports Field in Leeu-Gamka. Tenderers who arrive after 11H15 at the first clarification meeting will not be allowed to join the clarification meeting, or the second meeting as well. Tenderers are advised that the compulsory clarification meeting will be conducted in adherence to the relevant COVID-19 Lockdown Regulations promulgated for such assemblies.

**Bidders are required to be registered at the Construction Industry Development Board (CIDB).** Only those tenderers who are registered with the CIDB, in a contractor grading designation equal to or higher than a contractor grading designation determined in accordance with the sum tendered, or a value determined in accordance with Regulation 25 (1B) or 25 (7A) of the Construction Industry Development Regulations for a **1SL** class of construction work are eligible to have their tenders evaluated.

The closing time for submission of bids is **13h30 on Monday 03 May 2021**. Bids must be sealed in an envelope clearly marked with the bid number and title given above and placed in the **bid box at the Administration Building, 33 Church Street, Prince Albert**, on or before the mentioned time and latest date. **Telephonic, facsimile, e-mail and late bids will not be accepted.** Bids must remain valid for a period of ninety (90) days after the closing date of the bid. Notwithstanding the period for validity of bids as set out in the bid documents, bids shall be deemed to remain valid until formal acceptance by the Prince Albert Municipality of an offer at any time after the expiry of the original validity period, unless the Prince Albert Municipality is notified in writing of anything to the contrary (including any further conditions) by the bidder.

Bids will be opened on the same day at the Council Chambers (Municipal Administration Building) at 13h30. Late or unmarked bids will not be considered.

**Bids may only be submitted on the bid documentation that is issued.**

**This bid is subject to Local Production and Content.**

**Stipulated minimum threshold for local production and content for Steel value-added products of 100%.**

**The evaluation of this bid will be subjected to functionality scoring.** Bidders must obtain the minimum functionality score of **40 out of 50 (80%)** in order for the bid to be responsive. Bidders who do not meet the minimum functionality scoring as indicated, will be regarded as non-responsive.

Bids will be evaluated according to the **80/20** preference points system. The bids are subject to the Council's Supply Chain Management Policy, Preferential Procurement Policy Framework Act, 2000, and the Preferential Procurement Regulations 2017.

The Municipality reserves the right to withdraw any invitation to bid and/or re-advertise or to reject any bid or to accept a part of it. The Municipality does not bind itself to accept the lowest bid or to award a contract to the Bidder scoring the highest number of points.

**NO BIDS WILL BE CONSIDERED FROM PERSONS IN THE SERVICE OF THE STATE AS DEFINED IN THE MUNICIPAL SUPPLY CHAIN MANAGEMENT REGULATIONS (GOVERNMENT GAZETTE NO 40553 DATED 20 JANUARY 2017).**
